

# Granville County Juvenile Crime Prevention Council Request for Proposals

The Juvenile Crime Prevention Council (JCPC) has studied the risk factors and needs of Juvenile Court involved youth in this county and hereby publishes this Request for Proposals. The JCPC anticipates funds from the NC Dept. of Public Safety, Division of Juvenile Justice in the amount stated above to fund the program types specified below. Such programs will serve delinquent and at-risk youth for the state fiscal year 2017-2018 beginning on, or after, July 1, 2017. The use of these funds in this county requires a local match in the amount specified above.

The JCPC will consider proposals for the following needed programs:

Community Service/Restitution	Teen Court	Conflict Resolution/Anger Management

Of 50 youth coming to the attention of Juvenile Services , 26% (13 youth) were under the age of 12. Risk indicators also suggest that 36% (21) youth at intake reported some substance abuse needing further assessment and/or treatment; 81% or (46) youth at intake were reported to have either moderate or serious school behavior problems; 60% or (34) youth at intake lacked pro-social peer involvement; 37% or (21) youth at intake had parents unable or unwilling to supervise .

Peer Domain:	Indicators suggest that 83% or 42 youth coming to the attention of Juvenile Services have negative peer interaction. <u>55% or 28 youth had some or regular association with delinquent youth and 13% or 7 youth were gang involved.</u>
Individual Domain:	Indicators suggest that 45% or 27 youth coming to the attention of Juvenile Services have a need for substance abuse assessment and/or treatment services; 63% or (36) youth reported have a history of abuse and neglect; <u>58% or (33) youth at intake reported to need more MH assessment</u>
Family Domain:	<u>73% or (42) youth at intake reported to have parents with marginal supervision skills and 60% of youth at intake reported to come from families with criminal history or had family member under current court supervision</u>
School Domain:	<u>55% or (31) youth at intake were reported to have serious school behavior problems and 38% or (22) youth at intake reported to be performing below current grade level .</u>

- Applicants are being sought that are able to address items below:**
1. Program services compatible with research that are shown to be effective with juvenile offenders.
  2. Program services are outcome-based.
  3. The program has an evaluation component.
  4. Program services detect gang participation and divert individuals from gang participation.

Local public agencies, 501(c)(3) non-profit corporations and local housing authorities are invited to submit applications to provide services addressing the above elements.
