Commissioners Approve Pay Schedule Adjustment

Key Dates to Remember

Message from Interim County Manager, Doug Logan:

For way too long, Granville County's payroll has been somewhat confusing to many, and perhaps inconvenient to most. From filling out paper timesheets to trying to figure out annual and sick leave accumulations as well as comp-time and even WHEN the actual pay date will arrive, much less waiting month to month for the funds to show up in our bank accounts...well, it's easy to see that the system needs fixing!

Over the last year and a half, County Administration, Human Resources, Finance, and the Internal Auditing Departments, have worked diligently to identify the problems and come up with a solution that would work in the best interests of both our employees and the County Government process, all while keeping us in compliance with the many state and federal regulations regarding compensation.

At its regular meeting on Monday, August 8, 2022, the Granville County Board of Commissioners, on the advice of the above-mentioned staff, voted to purchase a new Human Resources software package that includes electronic time and attendance capabilities (no more paper timesheets!!). Due to the magnitude of transitioning to this new system, full implementation will be realized within the next 8-10 months. In order to get all the benefits of this, our pay schedules and other payroll details must also be adjusted.

"This will NOT involve any changes in your pay rate!" It will, however, change WHEN you get paid, and how frequently you get paid. For the majority of the County, no changes will be made until June 2023, so there is plenty of time to understand how it will affect you, and to make the necessary personal adjustments.

The County is committed to making this transition go smoothly for everyone and is planning to make professional financial assistance available as we head towards this transition, to explain the process and to help with personal budgetary modifications that may be required.

Stay tuned! There will be lots more information to come!!





Safety Corner - Ergonomics

CORRECT SITTING POSTURE



Ergonomics is defined as the study of how people work in their environment. Implementing workplace ergonomics can make employees more comfortable and increase productivity. In order to improve work ergonomics, experts give us five aspects for improvement which are Safety, Comfort, Ease of Use, Performance, and Aesthetics. A breakdown if the uses and importance of these 5 aspects are listed below:

Comfort: It is vital that employees performing repetitive movement such as lifting or moving objects do not have to continually overexert themselves. **Ease of Use:** Workers need to be able to perform tasks without awkward movements that put stress on necks, backs, knees, and even eyes. Trying new tools and techniques can help ease employees working conditions.

Performance: Productivity can be improved if performance can be reviewed and enhanced by applying ergonomic design.

Aesthetics: Focuses on the worker's protective gear, tools, other equipment, their workstation being easy to understand, function, operating procedures, and warnings.

Safety: Involves having tools, equipment, chairs, workstations and even assembly lines that decrease the stress of the worker doing the jobs.

Proper office ergonomics can include correct chair height, adequate equipment spacing and good desk posture which can help you and your joints stay comfortable at work.

A.J. Spiess Joins Veterans Services Office as VST



The Granville County Veterans Services Office has a new Veterans Services Technician (VST), Albert "A.J." Spiess. Spiess will work under the direction of Veterans Services Officer (VSO) Chris Dethmers to assist local Veterans and their families with navigating the complex processes to access Veterans resources at the state and federal level.

Originally from Lula, Georgia, Spiess is a retired Veteran of the U.S. Navy. Spiess began his twenty-six years of service after enlisting in Gainesville, Georgia and eventually rose to the rank of Senior Chief Master at Arms (Military Police). Spiess served on six ships (USS Butte, USS Simpson, USS Briscoe, USS Truman, USS Harpers Ferry, and USS Wasp). Before reaching the rank of Senior Chief Master at Arms, Spiess also served as Deck Seaman and Signalman.

Spiess also has extensive experience serving as Anti -Terrorism Officer/Physical Security Officer conducing antiterrorism training, Department Leading Chief Petty Officer/Lead Investigator where he investigated larcenies, assaults, suicides, and other security violations, and Senior Master Training Instructor at the Navy Police Academy overseeing major curriculum changes and teaching students at all levels of experience.

In addition to his professional experience, Spiess previously volunteered with the Disabled American Veterans (DAV), serving as Chapter Veterans Services Officer where he aided veterans and their families in obtaining benefits and services provided by the Department of Veterans Affairs (VA) and other government agencies.

Spiess also holds an associate degree in Criminal Justice and a bachelor's degree in Homeland Security and Emergency Management. He and his wife Corie have one child, Brooke, who is currently attending nursing school.

"I feel so privileged to serve Veterans and their families in Granville County," said A.J. Spiess. "I have always volunteered with various organizations throughout my life and when I retired and started volunteering with the DAV, I found my true passion. Recipe of the Month!

Ham it Up Crescent Rolls

1 8oz pkg crescent roll dough

8 slices deli ham (precooked)

1 cup shredded Swiss or cheddar cheese

2 Tbsp sesame seeds (optional)

4 tsp Dijon mustard



Preheat oven to 375 degrees. Unroll the crescent dough onto your kitchen work surface. Firmly press diagonal perforations to seal and separate into 4 long rectangles. Place 2 deli ham slices on each of the rectangles. Spread 1 teaspoon of Dijon mustard on each rectangle and sprinkle with 1/4 cup of Swiss or cheddar cheese. Starting at the shortest side, roll up each rectangle, press and seal. Optional: Coat each roll with sesame seeds. Cut each of the 4 rolls into 5 slices forming 20 slices total. Place cut side down on an ungreased cookie sheet. Bake the rolls in the preheated oven until the internal temperature reaches 140°F on a food thermometer and the crescent is golden brown.
