1 Harry Mills appointed to statewide economic development council.

Granville County Economic Development Director Harry Mills was recently appointed to serve as a member of the North Carolina Economic Development Advisory Council. This council provides advisory direction and support to the Economic Development Partnership of North Carolina (EDPNC).

Mills will represent the "North Central Prosperity Zone" along with Michael Haley, Executive Director of the Wake County Economic Development Office. Mills was appointed to serve on this council by the current members of the EDPNC Board and will represent a number of counties including Granville, Person, Vance, Warren, and Franklin.



"I'm excited to represent Granville County and I look forward to working with this group of my peers to attract new businesses to North Carolina," said Mills.
